PROPERTY DESCRIPTION: The property is comprised of a 282-bed Minimum Security Prison (Vacant) and 30 single family residence homes on one 30 acre parcel. There is a total of approximately 47 single-story buildings residing on the premises designating approximately 17 buildings to the prison and 30 staff homes. The 17 single story structures include; dormitory-style living quarters, administrative, gun, maintenance, kitchen/dining, intake/hold, laundry, multi-purpose, and generator buildings. Directly adjacent to the prison are 30 SFR Homes, consisting of (4) 4B/2B at approximately 1632 square feet, (18) 3B/2B at approximately 1317 square feet, and (8) 2B/2B at approximately 1045 square feet. Each home's amenities include an attached 2 car garage, washer/dryer hookups, and central air conditioning/heating. Prison's security features include 12-foot perimeter fencing topped with razor-wire. Gates feature dual magnetic locking mechanisms. Security/camera systems throughout prison.


