In today's address the Governor spoke to the importance of vaccination being the pathway out of the pandemic. Vaccination and masking will be our greatest tools against the Delta variant surge. "When we rolled back our mask mandate in May, Delta was less than 1% of cases. Today, it's greater than 90% in Nevada and, according to the CDC, vaccinated people exposed to Delta may be as contagious as unvaccinated, but have much less severe symptoms"

This week, the Governor sent a request to his medical advisory team for recommendations in three areas:

**First**, I am asking my medical advisors to look at vaccination requirements for all students attending in-person classes at our public colleges and universities under the Nevada System of Higher Education. Subsequent to my request to the MAT I was made aware that the NSHE COVID-19 has provided a recommendation unanimously recommends that the COVID-19 be required for anyone attending their institutions.

- Assuming that my medical advisory team is in agreement with those on the NSHE Task Force that

Today, Candice McDaniel, Deputy Director of Programs for the Nevada Department of Health and Human Services provided updates on Nevada's ongoing COVID-19 response and vaccination efforts during a call with members of the media.

### **MEDICAL ADVISORY TEAM (MAT) RECOMMENDATIONS**

As the COVID response has progressed and things have changed the State continues to consider all options and look at available resources to protect the health of our communities.

As Governor Sisolak discussed yesterday, he asked the Medical Advisory Team (MAT) to meet recently to discuss three topics:

- 1. Vaccination for higher education students;
- 2. Recommendations for those who work with vulnerable populations; and
- 3. Review of how to make large gatherings safer

When it comes to vaccination of Nevada System of Higher Education (NSHE) students, the MAT is agreement with the unanimous recommendation from the NSHE COVID-19 Task Force to require vaccinations. This is the first step in a layered recommendation process. The next step is to work with stakeholders and NSHE leaders to review timelines so regulations can be developed by the State Immunization Team and ultimately brought forward to the State Board of Health.

The State Board of Health is the final decider for passing school vaccine mandates by approving regulations drafted by the Division of Public and Behavioral Health.

The Governor recently announced that all State employees would either need to be vaccinated, or be tested for COVID-19 each week.

NSHE employees are subject to the State of Nevada employee policy requiring proof of vaccination or weekly COVID-19 testing.

The State will be providing updates related to the other requests made to the MAT as there is more information to share.

#### **VACCINATION**

If you received the Pfizer or Moderna vaccine it is extremely important to get both shots. This will provide the full protection against the virus. Even if you got your first dose but never made it back for your second shot, it is never too late to get your second dose and you will not need to start the vaccination series over.

At this time there is not evidence that pushing out the second dose makes it less effective.

Second, even if you had COVID-19 you should still get the vaccine. If you were ill recently, or have questions or a medical condition, you should speak to a trusted health care professional.

At this time, it is not known how long someone is protected from getting sick again after recovering from COVID-19. The immunity someone gains from having an infection, called "natural immunity," varies from person to person.

As of yesterday, 91,061 individuals ages 12 to 17 have been vaccinated.

Recently Elko County teens have seen an increase in vaccination, 44% of their vaccines in July were in the 12-18 year old age group.

Finally, when it comes to vaccination efforts being conducted by federal, state, local and community partners the State is seeing initial signs of success.

In addition to the overall increase in vaccinations, preliminary data on the efforts in targeted Southern Nevada zip codes where canvassing and outreach efforts have been conducted is showing an increase in those zip codes compared to zip codes where no canvassing has occurred.









# **COVID-19 Press Bulletin for August 6, 2021**

Carson City, NV — Today, Candice McDaniel, Deputy Director of Programs for the Nevada Department of Health and Human Services provided updates on Nevada's ongoing COVID-19 response and vaccination efforts during a call with members of the media.

This bulletin provides facts, figures, and informational items from the call. As a reminder, data is provided in a dashboard on the home page of the <u>Nevada Health Response</u> website.

## **SUMMARY:**

- Nevada is currently experiencing a surge in cases and hospitalizations similar to last summer's levels.
- Cases have not reached the same levels as last year, but are very close.
- Hospitalizations have surpassed last summer's levels and continue to grow, though at slowing rates. Hospitalization rates lag a few weeks behind cases.
- Efforts to mitigate this surge include the vaccine campaign, mask mandate in high transmission counties, K-12 masking, state employee vaccination and testing along with local governments and private sector businesses taking similar actions.

## **MAT RECOMMENDATIONS:**

# Governor Sisolak provides updates on COVID-19 in Nevada, seeks recommendations from Medical Advisory Team

LAS VEGAS, NV – Today, Nevada Governor Steve Sisolak provided an update on the State's efforts to slow the spread of COVID-19 in Nevada and outlined three requests he has sent to his Medical Advisory Team.

"Unless we increase our vaccination rates quickly, the virus will have time to mutate, the unvaccinated will continue to fill our hospitals and place unnecessary strain on our ability to treat all patients, and our economic progress will be threatened," **Gov. Sisolak said.** "That's why we're masking – to slow the spread as more Nevadans, as soon as possible, roll up their sleeves and get their shots."

The Governor outlined three requests he has already sent to the medical advisory team.

**First**, he is asking medical advisors to look at vaccination requirements for all students attending in-person classes at public colleges and universities under the Nevada System of Higher Education.

If the medical advisory team recommends required vaccinations for students, the Nevada Division of Public and Behavioral Health will bring forward proposed regulations to the State Board of Health for consideration.

Public health officials have already begun discussions with the appropriate partners, including those at NSHE, to explore implementation on a timeline

that would consider how long it takes to complete full vaccination with the upcoming academic calendar.

The Governor's request will have NO impact on the ability of students to return to classes this semester. If this is the direction taken, health officials will work with NSHE and higher education partners to make sure any timeline is fair and reasonable.

**Second**, the Governor asked the Medical Advisory Team for a vaccination recommendation regarding those who work with vulnerable populations, like those in institutional settings, those working with the homeless community and those working in our health care system.

These recommendations will help guide conversations and actions the State can take moving forward. More updates will be provided as recommendations reviewed and conversations begin with impacted parties and local officials.

**Finally**, the Governor has asked these medical advisors to look at how Nevada can make large gatherings safer, understanding that the Delta variant is more infectious than anything the State has seen before in this pandemic.

When the recommendations come back, the State will work with local officials, event managers, and operators of the state's largest venues to discuss how they can best implement safety protocols. The Governor is hopeful the private sector will continue to work with the State to accomplish these goals without a government mandate or a directive.



**Subject:** Press Conference Highlights

In today's address the Governor spoke to the importance of vaccination being the pathway out of the pandemic. Vaccination and masking will be our greatest tools against the Delta variant surge. "When we rolled back our mask mandate in May, Delta was less than 1% of cases. Today, it's greater than 90% in Nevada and, according to the CDC, vaccinated people exposed to Delta may be as contagious as unvaccinated, but have much less severe symptoms"

This week, the Governor sent a request to his medical advisory team for recommendations in three areas:

**First**, I am asking my medical advisors to look at vaccination requirements for all students attending in-person classes at our public colleges and universities under the Nevada System of Higher Education. Subsequent to my request to the MAT I was made aware that the NSHE COVID-19 has provided a recommendation unanimously recommends that the COVID-19 be required for anyone attending their institutions.

- Assuming that my medical advisory team is in agreement with those on the NSHE Task Force that
  believe this is necessary for Nevada's higher education institutions to join the hundreds of colleges and
  universities around the country in requiring COVID-19 vaccinations, the Nevada Division of Public and
  Behavioral Health will bring forward proposed regulations to the State Board of Health for
  consideration.
- Public health officials have already begun discussions with the appropriate partners, including those at NSHE, to explore implementation on a timeline that would consider how long it takes to complete full vaccination with the upcoming academic calendar.
- I want to assure those returning to campuses in the coming weeks that this will have NO impact on your ability to return to classes this semester. If this is the direction taken, health officials will work with NSHE and higher ed partners to make sure any timeline is fair and reasonable.

**Second**, I am asking the Medical Advisory Team for a vaccination recommendation regarding those who work with vulnerable populations, like those in institutional settings, those working with the homeless community and those working in our healthcare system.

• These recommendations will help guide conversations and actions we can take moving forward. I am not afraid to take bold action and I look forward to reviewing the guidance and working with officials and partners to implement as necessary.

• More updates will be provided as we review recommendations and begin conversations with impacted parties and local officials.

**Finally**, I am asking these medical advisors to look at how we can make large gatherings safer. Nevada is an incredible location for concerts, sporting events and so much more. We have a mask mandate in place, and I implore all Nevadans attending a large gathering to take it seriously and keep their masks on.

- However, understanding that the Delta variant is more infectious than anything we've seen before in this pandemic and having thousands of people in indoor settings many of whom are unvaccinated, is high risk. That's why I've asked for recommendations on how these venues and large gatherings can do this right and how we protect one another.
- When I get these recommendations back, I will be working with local officials, event managers, and
  operators of our largest venues to discuss how they can best implement safety protocols. We've all
  seen private sector leaders step up to help in these efforts, and I'm hopeful they'll continue to work
  with us to accomplish these goals without a government mandate or a directive.

The Governor stated that as these recommendations come back, you'll be hearing updates from him and state officials. Again- our goal is to avoid rolling back. When adults get vaccinated, they protect those who can't. And because children under 12 are unlikely to become eligible for a few more months, we have an obligation to help protect them and help ensure they have a smooth and successful school year.
