# Jailed for sex assault

Alan E. Bigelow, a firefighter with the Pahrump Valley Fire Rescue Service, is still in custody at the Nye County Detention Center after being arrested and booked on three counts of sexual assault last week.

Bigelow's bail was originally set at \$150,000 but was reduced to \$50,000 in a hearing Friday.

The alleged assault was first reported by the unnamed victim Wednesday, July 27.

The investigation, handled by Dep. Dawn Moore, revealed the victim had gone to Bigelow's residence for a massage, a sheriff's office press release said.

The press release states Bigelow assaulted the victim three times against her will.

A search warrant was executed at Bigelow's residence where "numerous items were discovered and taken as evidence," the report stated.

Authorities had to search for Bigelow, who reportedly did not show up for work the next day.

He gave detectives two separate times to meet with him through his attorney. Detectives finally arrested him Sunday, July 31.

# Alan Bigelow bail reduced, - Preliminary hearing is set

Bail for local firefighter Alan Bigelow, who late last month was arrested on charges of sexual assault, was reduced Friday during the defendant's formal arraignment in front of Judge Tina Brisebill.

The judge also set Bigelow's preliminary hearing for Aug. 22 at 10 a.m.

Brisebill dropped bail from \$50,000 to \$25,000 cash or bond, after hearing from stand-in defense attorney Jason Earnest, who argued Bigelow's strong ties to the community.

"Mr. Bigelow has been a member of this community for six years," he said. "You have a man who, I believe, is no flight risk."

In addition to serving with Pahrump Valley Fire Rescue, Bigelow volunteers at a local TV station and, in 2006, ran for a seat on the Nye County Commission.

Earnest, who in court asked that Bigelow be released on his own recognizance, later said he was pleased with the bail reduction.

"I think that was a very reasonable decision by Judge Brisebill," he said.

Earnest represented Bigelow in place of the defendant's attorney. Tom Pitaro.

About a dozen people, including Justice of the Peace candidate Linda DeMeo, County Commissioner Butch Borasky, and local activist Ray "The Flagman" Mallow, attended the hearing.

Bigelow was arrested July 31 after an unnamed woman contacted the sheriff's office, alleging Bigelow had sexually assaulted her.

According to the sheriff's office, the alleged victim had gone to Bigelow's home for a massage.

Detectives conducted a search of his home, during which "numerous items were discovered and taken as evidence."

# NARRATIVE:

On July 28, 2008 at approximately 0800, Detective Boruchowitz and I, Detective MacNeil, spoke with the *victim*. (The *victim* will be referred to as pursuant to NRS 200.3771 and 200.3772) The interview was digitally recorded.

I asked the *victim* to tell us what happened on the night of July 25, 2008. The *victim* stated that she had met up with her friend, and her son for dinner at Wulfy's. The *victim* stated that she saw Alan Bigelow with another lady who she knew as . The *victim* stated that she started talking to and Alan about different things and then stated that the subject of a massage came up. The *victim* stated that she knew that Alan gave massages to a friend of hers named. The *victim* stated that she was supposed to have scheduled a massage with Alan a few months back but didn't. The *victim* stated that she and Alan discussed how much he would charge her for the massage and he came up with the amount of \$40. The *victim* then stated that Alan suggested that she come over then to his house and he would give her a massage that evening. I asked the *victim* what time this was and she stated that it was between 2030 hours and 2100 hours.

The *victim* stated that she then followed Alan in her own vehicle to his house. The *victim* stated that she remembered parking near a tree that was by the garage. The *victim* stated that she went into Alan's house and he went into his bedroom, where he was going to give her the massage, and got the bed ready by putting a maroon colored towel on the bed. The *victim* also stated that he changed into a pair of thin, blue colored material sweat pant type pants and a white t-shirt. The *victim* then stated that once Alan came out of the bedroom, he told her to go in and get changed and that there was a towel on the bed for her to wrap up in. The *victim* stated that she then went into Alan's bedroom and took her clothes off, but left her bra and panties on, however she later unclasped her bra. The *victim* then stated that she had wrapped herself in a white towel that was left for her. The *victim* stated that she then laid

on the bed with her head resting at the head of the bed. The victim stated that Alan came into the room then and asked her to turn around so that her head was resting at the foot of the bed. The victim then stated that Alan proceeded to give her a massage. The victim stated that when Alan was finished massaging the back of her body he asked her to turn over onto her back. The victim stated that she turned over onto her back and stated that Alan asked her to hang her head over the edge of the bed.

The victim stated that when she was lying in the position described above, the victim stated that Alan then forced his penis into her mouth. The victim stated that when Alan had his penis in her mouth he then laid on top of her and proceeded to orally copulate her vagina with his mouth. The victim stated that she was very scared because she couldn't breathe because Alan's groin area was covering her mouth and nose. The victim stated that it felt like he was biting her vagina and then she stated that she felt an excruciating burning sensation on her vagina. The victim stated that she didn't know what was causing the burning sensation. The victim stated that Alan then got up off of her and went to the side of the bed and the victim stated that she heard a crinkling sound, that of maybe the wrapper of a condom. The victim stated that Alan then got back on top of her and put his penis inside of her vagina and started to have sex with her. The victim stated that she told Alan that she wasn't there for that (sex). The victim then stated that when Alan finished he got up and went into the living room.

I asked the victim why she didn't try to scratch, push Alan off of her or leave the house when he got up to put the condom on. The victim stated that she couldn't believe that this was happening to her and she went into survival mode. The victim stated that she was in fear for her life and didn't know what Alan would do. I asked the victim why she didn't report the sexual assault the same day. The victim stated that she was afraid because of who Alan worked for. (Alan is an employee of Pahrump Valley Fire Department and an independent contractor of Channel 41.)

The victim stated that once she got dressed and was leaving, Alan stated to her that she could pay him next time for a massage. The victim stated that she had left his house and went to her car and while she was in her vehicle, she realized that she had left her eyeglasses in Alan's room. The victim then stated that she couldn't see without them and had to go back to his apartment to retrieve them. I asked the victim what time she left his residence. The victim stated that she left his residence approximately 2147 hours. I asked the victim how she knew it was at that time she had left. The victim stated that she had received a phone call from her boyfriend at that time to meet him and his friend at Paddy's Bar.

The victim also stated that she had I asked the victim if she had told her boyfriend, contacted No To Abuse Hotline, a physician from Desert View Regional Medical Center, a few coworkers, a friend and her son. They all had advised her to contact the police and make a report. I asked and her. The victim stated that things were good and that the victim how things were between he has been supportive of her. I asked how things were between them before the assault occurred. The and things were good between the two of them even victim stated that she just started dating before the assault.

I asked the *victim* if she went to UMC for the SANE exam as Deputy Moore had advised her to do. The *victim* stated that she didn't go to UMC for the exam because she felt intimidated to be there. The *victim* stated that she did go to her physician, Dr. Bady. The *victim* stated that she gave him permission to release his medical report to the Sheriff's office. The *victim* stated that Dr. Bady had taken cultures and examined her. The *victim* stated that Dr. Bady had told her that there was trauma to her vagina. However, Dr. Bady did not take photographs. As of July 31, 2008 I have not received a copy of that report.

During my interview with the *victim* she became emotional when talking about the sexual assault. The *victim* would start to tear up and then she would start to cry. The *victim* appeared to be sincere about what had occurred to her. The *victim* was interviewed three times and her story didn't change.


On July 30, 2008 a search warrant was then obtained by the Honorable Judge Brisbell for Alan's house and person. At approximately 1054 hours on July 30, 2008, entry was made into Alan's residence. See return of service for the evidence collected at Alan's residence.

On July 31, 2008 numerous attempts were made to contact Alan for his buccal swab. Alan spoke with Detective Chandler and informed him that he had made an appointment with Detective Boruchowitz for 2000 hours on this date. I made contact with Detective Boruchowitz and he stated that he told Alan to come to the Sheriff's office whenever he returned to Pahrump. Detective Boruchowitz had spoken with Alan on July 30, 2008 and Alan informed him that he had called off sick to obtain a lawyer and that he was staying in Las Vegas that evening and would return the following day. Detective Chandler was able to make arraignments for Alan to meet us at the Terrible's Country Store for the search warrant for his buccal swab. Alan was in his Jeep waiting for Detective Chandler and I. Alan was given the search warrant for his buccal swab. I then obtained the buccal swab from Alan. I then placed Alan under arrest for the aforementioned charges.

On July 27, 2008, at approximately 0953 hours, I was dispatched to for a report of a sexual assault. Upon my arrival, I spoke with the victim (confidential), who said that she was raped on Officer Structure ID#: Event #: Approved: By / ID# Approval Date 1988 08-2000 | Sexual Sexual





Friday night, July 25, 2008. The victim said that on Friday, at approximately 6:15 p.m., she went to Wulfy's to have dinner with a friend, ... and son. The victim said that after dinner, at approximately 8:30 p.m., she ran into a friend, her escort, Alan Bigelow.

The victim said that a mutual friend, , had told her to ask Mr. Bigelow about a massage. The victim said that when the subject of massages came up, she told Mr. Bigelow that she wanted a massage, and he agreed, stating that the cost was \$40.00. The victim said that she said, "Okay," and Mr. Bigelow told her to follow him to his residence. The victim said that they went to an address off of Pocahontas, but she is not sure of the exact address.

The victim said that when they got into Mr. Bigelow's residence, he took her to the bedroom and laid out a large, maroon-colored towel on the bed. The victim said that Mr. Bigelow left a large, white towel for her to cover herself with and left the room so she could get ready. The victim said that she took off her top and her pants but left on her underwear and her bra (after unhooking the bra). The victim said that she then laid down on the bed with her head at the head of the bed and then called Mr. Bigelow and said that she was ready. The victim said that Mr. Bigelow came into the room and told her he wanted her head at the foot of the bed and then left the room again. The victim said that she repositioned herself, and Mr. Bigelow came back into the room and began the massage.

The victim said that Mr. Bigelow stood at the foot of the bed and began rubbing her back. The victim said that Mr. Bigelow then turned her over and laid her on her back, with her head over the end of the bed. The victim said that Mr. Bigelow then removed his sweats and inserted his penis into her mouth. The victim said that she tried to push him away, but he laid on top of her and removed her panties. The victim said that she could not breathe, and she kept pushing him away, but that he kept going and then began to perform oral sex on her.

The victim said that Mr. Bigelow finally stopped, and that she was crying and saying that she did not want to do this, that she just wanted to go home. The victim said that she then heard the sound of crinkling and thought it may have been a condom. The victim said that Mr. Bigelow then got on top of her, facing her, and penetrated her. The victim said that she kept telling Mr. Bigelow, "No," and, "I don't want this," and he said, "Yes, you do. I'm going to make you cum." The victim said that Mr. Bigelow held her arms down as she was struggling, and she continued to tell him, "No." The victim said, "He was hurting me."

The victim said that when he was done, he got off of her and left the room. The victim said that at that time, she got dressed and left the residence, but as she passed through the living room, Mr. Bigelow was on the couch and said to her that, "There's no charge this time, but next time it would be \$40.00."

The victim said that she was driving home and realized she had forgotten her glasses and had to return to the residence to get them. The victim said that it took her a few tries to knock on the right door, and

when Mr. Bigelow answered, she told him that she forgot her glasses. The victim said that Mr. Bigelow went into the bedroom, got her glasses, and gave them to her.

The victim said that she called a friend of hers, , and told her what had happened. The victim said that due to her employment and Mr. Bigelow's employment, she was afraid to report this incident. The victim said that she spoke with several people on Saturday regarding the report/don't report issue and finally decided to call and speak with a detective.

After the interview with the victim, the victim provided me with the clothing that she was wearing that night, and those items were bagged separately and booked into evidence for the detectives to submit for testing. The victim also drew a layout of the suspect's residence, labeling rooms, furniture, etc. That was also copied and booked into evidence. A written statement was obtained however the victim's name was not completed on said statement, a pseudonym will be included in this case file.

On July 27, 2008, at approximately 1600 hours, Alan Bigelow came to the Sheriff's Office for a interview at my request. Mr. Bigelow was interviewed in the break room at the Sheriff's Office, and he was told from the very beginning that he could leave at any time. Mr. Bigelow said that he did know the victim, and he had met the victim at Wulfy's on Friday, and she gave him a hug, and they talked for a few minutes. Mr. Bigelow said that he told the victim that he was leaving to go home, and the victim asked if she could join him.

Mr. Bigelow said that when they got to his residence, they talked about her divorce, and she hugged and kissed him on the neck. Mr. Bigelow said that he and the victim then went into his bedroom, and the victim took off her clothes and invited him to join her. Mr. Bigelow stated that he and the victim did have sex, but it was consensual. After sex, the victim then got dressed, used his bathroom, and then he walked her to the door, and she left. Mr. Bigelow said the victim did come back about ten minutes later because she forgot her glasses, and he found them and gave them to her, and she gave him a goodnight kiss. Mr. Bigelow stated that he was at Wulfy's with a friend ... during the initial meeting with the victim but also stated that at no time did he offer a massage for money or as a come-on to have her join him for sex.

Mr. Bigelow refused to submit to a Computer Voice Stress Analysis Test and stated that this was due to the amount of stress in his life at this time. A written statement was obtained.

said that the following morning, Saturday, at approximately 7:46 a.m., she received a call from the victim, telling her that on Friday night she went to Mr. Bigelow's house for a massage, and that he raped her. said that she asked the victim if she was dressed, and the victim told her that her shirt was off, and her bra was undone. said that she did not ask anymore questions because the victim was crying too hard. said that the only detail the victim gave her was that Mr. Bigelow was wearing a condom. said she told the victim that she had to make a report on it, but the victim said she was scared of Mr. Bigelow's background. A written statement was obtained from this witness.

On July 28, 2008, at approximately 0900 hours, I contacted who said that she has known Mr. Bigelow and the victim for about two-and-a-half years. stated that Mr. Bigelow has given her massages a few times, and that she did recommend him to the victim. said that she thought the victim needed a massage and brought the subject up with Mr. Bigelow. said that Mr. Bigelow said that he did not remember the victim, but that it would not be a problem. A written statement was obtained from this witness.

# **Executive Summary**



2. The first project of this engagement consisted of a thorough investigation into all matters associated with Alan Bigelow's background and digital footprint. The methodologies employed during the Bigelow investigation consisted of "behind-the-keyboard" investigative techniques, including the acquisition and analysis of background investigation reports, open-source and social media intelligence gathering, and direct contact with several governmental agencies.

The investigation yielded one critical severity finding: Bigelow was arrested and accused of sexual assault by the Nye County Sheriff's Office in 2008. An unnamed female accused Bigelow of sexual assault after she allegedly went to Bigelow's home for a massage. The case was eventually dismissed by Nye County District Attorney in January 2011.

Three high-severity findings were identified regarding Bigelow's financial history. In 2007, he filed for Chapter 7 bankruptcy, wiping out over \$53,000 in debt as a result. He had nine liens totaling over \$2,000 filed against him by the City of Las Vegas and Republic Services from 2013 – 2016 for unpaid trash and sewer bills. And in 2010, Bigelow had his Pahrump, NV home foreclosed on. An additional high-severity finding was identified in the fact that Bigelow's exwife currently resides in Pahrump; property records indicate they split around the time of Bigelow's sexual assault case. Additional findings include that Bigelow was possibly a defendant in a Clark County personal injury case in 2015. The case settled for just over \$4,000.

# Summary of Scope, Methodologies & Findings

The scope of this background investigation included Alan Bigelow and close family relatives and associates: his ex-wife Pamela DiMaggio, his sister Angela Breidenbach and his half-brothers John Lee Bigelow and Christopher Bruce Bigelow.

The methodologies employed during the investigation consisted of "behind-the-keyboard" investigative techniques, including:

- The acquisition and analysis of Comprehensive Background, Open-Source Intelligence (OSINT) and Social Media Intelligence (SOCMINT) Reports from a total of three third-party data brokers.
- OSINT research, to include searches of the world-wide-web and the dark web, for pertinent intelligence.
- SOCMINT research, to include in-depth reviews of all identified social media accounts.
- Telephonic and email contact with several key governmental agencies for intelligencegathering purposes.

As a result of these methodologies, JDCI arrived at the following findings:

An unnamed female accused Bigelow of sexual assault after she allegedly went to Bigelow's home for a massage. The case, Nye County Fifth Judicial District Court case number CR0005820, was eventually dismissed by Nye County District Attorney in January 2011.




Figure 1 — Partial screenshot of Appendix 1 - Nye County Fifth Judicial Court Case # CR5820 Docket

## Explanation

According to open-source research, Chapter 7 bankruptcy is a type of bankruptcy that can clear away many types of unsecured debts. The Chapter 7 bankruptcy process begins when an individual files for the bankruptcy in federal court. Upon filing, the court places an automatic temporary stay on the filer's current debts, stopping creditors from collecting payments, garnishing wages, foreclosing on a home, repossessing property, evicting, and turning off utilities. The court takes legal possession of any property and appoints a bankruptcy trustee to the case. The trustee's job is to review the filer's finances and assets and oversee the bankruptcy. At the end of the process, approximately four to six months from the initial court filling, the court will discharge the filer's eligible debts, meaning the filer won't have to pay them anymore. A Chapter 7 bankruptcy remains on credit reports and can severely negatively affect the filer's credit scores for ten years from the filing date.

On 05/30/2007, Bigelow filed a voluntary petition for individual bankruptcy, Chapter 7, in United States Bankruptcy Court, District of Nevada. His case was assigned case number 07-13183-lbr. A copy of the voluntary petition filed by Bigelow is attached to this report as Appendix 6 and incorporated herein.

Upon discharge, Bigelow received relief from a \$30,942.17 automobile loan and \$22,137.63 in credit card debt. A copy of the trustee's final distribution report is attached to this report as Appendix 7 and incorporated herein.




Figure 3 – Alan Bigelow Foreclosure Summary




# Explanation

Amanda Cornelius was listed as the petitioner on behalf of subject minor Anaia Cornelius. The case was classified as a Compromise of Minor's Claim case.
